In connection with the previous disclosure of Greenergy Holdings Incorporated ("Greenergy") dated 4 December 2012 on the execution by its subsidiary, Biomass Holdings, Inc. (BHI), of an Investment Agreement with San Carlos BioPower, Inc. (SCB) under which BHI shall acquire a 64% equity interest in SCB for a total consideration of Php667,527,300.00 (the "Total Investment Price"), Greenergy hereby discloses that BHI has executed an Addendum and Amendment to the Investment Agreement (the "Addendum").

Under said Addendum, BHI shall release the Total Investment Price to SCB on 06 March 2013, which amount shall be treated as a deposit for future subscription to common shares of SCB from the latter's increase of authorized capital stock.

The release of the Total Investment Price to SCB completes the investment of BHI in SCB for the acquisition of 64% equity interest in SCB and shall enable SCB to commence the implementation and construction of the 18 megawatt bagasse-fired power generation project in San Carlos City, Negros Occidental (the "Project"). The Project was issued its Certificate of Registration by the Board of Investments on December 21, 2012 and, on February 13, 2013, was confirmed by the Department of Energy (DOE) to have satisfactorily met the requirements to avail of the Feed-in-Tariff rates when it begins commercial operations in early 2015 as part of the first 250MW of installed biomass power capacity. With these, the Project is set to formally begin construction on April 2, 2013.
